# 2010 VOLUNTEERS OF THE YEAR NOMINATION RULES

A single nominator and/or organization may submit a total of three nominations for the 2010 Volunteers of the Year. More than three (3) nominations representing a group, organization, business or agency will not be accepted and all nominations will be returned. The resubmission of the three (3) nominations must be received by the nomination deadline.

Nominations must be made in one of the following categories:

## INDIVIDUALS

- **ARTS** – participating in activities promoting the cultural life of the community.
- **CIVIC SERVICES** – participating in activities to encourage civic involvement, dedicated to improving citizenship or enhancing the quality of life in the community.
- **EDUCATION** – participating in activities related to creating and/or supporting an environment where knowledge flourishes. This may or may not relate to a classroom setting.
- **RELIGION** – participating in the development and/or support of religious activities.
- **SOCIAL SERVICES** – participating in activities or programs contributing to the well being of people.
- **YOUTH** – for middle or high school students participating in outstanding volunteer work.
- **PROFESSIONAL MANAGER/COORDINATOR OF VOLUNTEERS** – for paid professionals employed as managers or coordinators promoting volunteerism. For more information on this category, call 599-2181.

## GROUPS

- **NONPROFIT ORGANIZATION/CLUB** – 501(c)(3) organizations, clubs, neighborhood associations or groups (adult and/or youth) that have contributed significant volunteer service to the community.
- **BUSINESS/GOVERNMENT AGENCY** – private businesses; workplaces; or federal, state or local government agencies or offices that have contributed significant volunteer service to the community.

Attachments may not exceed three (3) pages.

All attachments (pamphlets, newspaper clippings, pictures, supplemental answers, letters of recommendation, etc.) must be no larger than 8 ½ by 11 inches. They must be clearly marked as to which of the five judging criteria they are supporting. Unmarked materials will not be considered in the judging process. Do not submit films, dvds, cds, videotapes, audiocassettes or scrapbooks. All nomination packets and other materials become property of the *Tallahassee Democrat* and may be used for publication.

All nomination forms must be complete at the time of submission to the *Tallahassee Democrat*. A nomination form not completely filled out or received after the deadline will not be considered for judging.

We reserve the right to place nominees in the most appropriate category. Decisions of the judges are final. All nomination packets must be received no later than 5 p.m. on Monday, March 1, 2010.

A nominator cannot nominate anyone in his or her immediate family in any category.

A single nominator and/or organization may submit a total of three nominations for the 2010 Volunteers of the Year. More than three (3) nominations representing a group, organization, business or agency will not be accepted and all nominations will be returned.
